CLONMEL CREDIT UNION MEMBER'S DRAW RULES

- 1) The draw commenced in August 1999 and continues monthly thereafter until the Board of Directors of Clonmel Credit Union Limited (hereafter called the Board of Directors) deem otherwise.
- 2) The entrance fee of €33 per annum per member will be deducted in advance from savings or as defined from time to time by the Board of Directors. This is a non-refundable flat fee for annual membership of the draw.
- 3) Prizes will be at the sole discretion of the Board of Directors.
- 4) The members draw is a promotional event and in the interest of transparency, limited personal information belonging to winners will be disclosed publicly, such as your name, the general area you live in, and the prize amount.
- 5) Participation in the draw is limited to eligible members of Clonmel Credit Union Limited and they must be over 18 years on or before the draw date.
- 6) You must be living person at the time of the draw to win a prize.
- 7) Both members of a joint account are entitled to an equal share of the prize.
- 8) Non personal accounts are not eligible to join the members draw.
- 9) Volunteers and staff of Clonmel Credit Union are entitled to enter the member draw. They are subject to the same entry requirements and rules as other members.
- 10) Winning members will be notified personally.
- 11) All draws will be held in the Clonmel Credit Union Offices.
- 12) A register of entrants will be maintained at the Clonmel Credit Union Offices.
- 13) Membership of the draw must be completed prior to participation and no entry is valid unless full fees are paid and credited in advance.
- 14) Financial accounts at each year end will be audited by the auditor and presented at the A.G.M.

- 15) The draw is a cash draw.
- 16) The draw will be non-profit making and any surplus funds will be disposed of by way of extra draws.
- 17) All eligible members can elect to participate in the draw only if written authorisation is received or delivered to the Credit Union office at commencement stage or subsequently at the beginning of each financial year (i.e. October), or anytime the Board deem appropriate.
- 18) In the event that the winning member is a person who is in arrears or default in carrying out financial commitment or obligation to the Credit Union, the Board of Directors may make a decision to withhold delivery of the funds won by the member until the arrears have been paid or the default has been rectified. Such decision of the Board of Directors will be notified in writing to such member and if within seven days of the member being notified, he/she has failed to comply with requirements of the Board of Directors in relation to such arrears or default, they shall be entitled to pay over to the winning member the net proceeds after deducting any such arrears or paying any monies required to remedy such default.
- 19) The decision of the Board of Directors concerning the foregoing rules, amendments to the rules, or any matter arising from the monthly draw, will be final and not subject to appeal.
- 20) You may opt out of the member's draw at any time by returning the 'Opt Out' Form attached.
- 21) If there are insufficient funds in your member account when the entry fee for the draw is due, you will automatically be excluded from the draw. You will need to reapply at the next available opportunity.
- 22) Applications for entry to the draw can only be accepted from the member, the owner of the account. Applications will not be accepted from persons with authority to operate other aspects of the members' account.

MEMBERS' DRAW - SHORT FORM DATA PROTECTION NOTICE

YOUR PERSONAL DATA
For the purposes of operating the member draw, we will collect and process the following personal data: your name, account number, address, account balances, telephone, your image and other relevant information.

WHY DO WE COLLECT THIS PERSONAL DATA?
The members draw is a marketing activity used to promote the credit union and, as such, your express consent is required before you will be entered into the draw and your personal data is processed.

The publication of limited personal data belonging to prize winners is also a feature of the draw. This is used as a control to ensure the existence of legitimate prize winners can be verified in a transparent manner.

LAWFULNESS OF PROCESSING
We process this personal data

- with your consent to perform our contract with you in relation to your entry in the members draw
- to comply with our legal obligations in relation to the transparency and management of members draws
- for the purposes of the legitimate interests which we pursue in providing a well-managed member draw with prizes for the benefit of the consenting members, where such interests are not overridden by your interests or fundamental rights or freedoms which require the protection of your information.

Your current arrears profile in the credit union (where relevant) will be considered as part of any decision to withhold the payment of prizes as per the terms and conditions of the draw, as per the draw rules.

YOUR RIGHTS

You are giving your consent for your personal data to be processed to facilitate your requested entry to the members' draw. You can withdraw this consent at any time by completing the opt-out form. Withdrawing this consent means you will no longer be part of the members' draw.

Should you be unhappy with how the credit union is processing your data, you also have the right to request from the us access to and rectification or erasure of personal data or restriction of processing concerning you, or to object to processing, as well as the right to data portability. You can also lodge a complaint at any time with the Data Protection Commission.

DATA RETENTION

We keep your data relating to the members' draw while you are a paid-up member of the draw and for seven years after the draw closes, or after you leave the draw, either by withdrawing your consent, by having insufficient funds to pay the entry fee, or by closing your account with us, whichever comes first.
